

## **LICENSE AGREEMENT FOR SUPPORTED END OF LIFE TRAINING MATERIALS**

### **1. License Grant**

### **4. Intellectual Property**

- 4.1 All intellectual property rights in and to the Materials remain exclusively with the University (and relevant contributors). The User may not claim ownership, remove University or Programme branding, or represent the content as their own.
- 4.2 Nothing shall prevent the University from modifying, updating, or replacing the Materials at any time, including publishing revised versions or withdrawing outdated content.

### **5. Modifications and Derivatives**

The User is permitted to modify, adapt, translate, or create derivative works ("User Works") based on the Materials, provided that (a) the original source Materials are clearly and accurately attributed, (b) any modifications, adaptations, or additions are clearly identified and

distinguishable from the original Materials, (c) all such User Works are governed by the same licence terms as the original Materials and remain freely accessible for educational purposes, and (d) ownership of the original Materials shall remain at all times with the University, and nothing in this clause shall be construed as transferring any intellectual property rights in the original Materials to the User..

The University does not warrant that the content is accurate, complete, current, or fit for any particular purpose.
